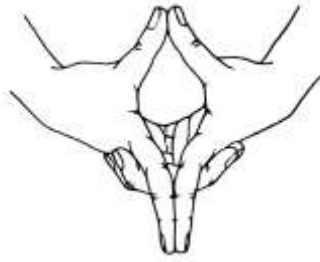

ITY Registration

Course Registration: The ITY course is in high demand and limited space is available. Students who register by completing this form are given preference with a guaranteed place on the course. Your final commitment is secured by a cash or internet deposit of R550 which is credited to your total debt payments for the course. The ITY Course requires a commitment to a 12 month contract with the Satyam Yoga School. Registration will secure your place until the course begins on Feb 4th 2012. The following conditions apply to the registration deposit and completion of the course.

1. The ITY course is open to all students regardless of previous experience. Students who join later in the year may attend a refresher workshop if required (not compulsory) at an additional cost to cover any previous content they have missed.
2. A non refundable deposit of R 550 is required to secure your place. This deposit entitles the registered student to a trial period of one month's unlimited access to all classes.
3. After completing your trial period of one month's classes you must sign the authorization to debit your monthly fee of R450 on the following page before you can continue with the course.
4. If you do not sign the contract you may continue classes at the school subject to a cash payment in advance of R550 each month or the casual fee of R 90 per class.
5. The course begins on February Feb 4th 2012 and will continue with classes each week until December 16th 2009.

Full Membership Contract: This contract offers the student unlimited access to all classes held at the school plus a 10 % discount on all sale items and generous discounts on workshops that are not part of the weekly class schedule.

I agree to a monthly fee of **R 450 (four hundred and fifty rand)** which shall be debited each month from my account for a minimum period of 12 months. I understand that I cannot cancel this contract until the 12 months are complete. I also accept that I must notify the school 30 days in advance to cancel this contract. The fees may not be increased during this 12 month contract period **beginning** / / **2012** **and ending** for a complete period of 12 months after which the above mentioned student may cancel or renew their membership subject to a 30 day cancelation notice.

Important: A cancelled cheque or a photocopy of the top letterhead of a bank statement that clearly displays your name and branch account number should be attached. This is simply a safeguard to ensure the details above are correct especially if they are hand written.

I/We hereby request, "Instruct" and authorize you to draw against my/our account with the above mentioned bank (or any other bank or branch to which I/We may transfer my/our account) the sum of **R 450 (four hundred & fifty rand)** on the first day of each and every month commencing on2012 and continuing until cancelled (as the case may be). All such withdrawals from my/our bank account by you shall be treated as though they had been signed by me/us personally.

I/We understand that the withdrawals hereby authorized will be processed by computer through an approved (government) internet based system known as Netcash. I also understand that details of each withdrawal will be printed on my bank statement as a debit for Yoga Fees by Netcash. I/we understand that I/we shall not be entitled to any refund of amounts which you have withdrawn while this authority was in force if such amounts were legally owing to you. Receipt of this instruction by you shall be regarded as receipt thereof by my/our bank (whichever it is or will be).

Cancellation: The account holder who has signed this authority may not cancel until the 12 month period has expired (calculated from the date of signing). You will be notified 60 days prior to the end of the 12 month contract advising you of the expiry date and a request from you to continue or cancel. You the account holder must provide a 30 days' notice of your intention to cancel which may be sent by email 30 days prior to the end of the calendar month.

I/We acknowledge that the party hereby authorized to effect the drawing(s) against my/our account may not cede or assign any of its rights to any third party without my/our written consent and that I/we may not delegate any of my/our obligations in terms of this contract/authority to any third party without prior written consent of the authorized party.
